Recall Description

The Occupant Classification System (OCS) is designed to classify the size and weight of the front seat passenger and, under certain conditions, automatically turn OFF the passenger air bag. The OCS system is designed to only deploy the front passenger airbag when the front passenger seat is occupied by an adult. In the affected vehicles, the OCS software may incorrectly classify the passenger seat as empty when it is occupied by an adult. If the OCS does not detect an adult occupant in the passenger seat, the passenger airbag would be deactivated.

Remedy

Nissan is currently awaiting parts to remedy the affected vehicles. Nissan will send you a second letter, when parts are available, asking you to bring your vehicle to a Nissan dealer for the remedy at that time. This repair is free of charge for parts and labor. In the meantime, if you believe there is an issue with the OCS system in your vehicle, you may bring your vehicle into the nearest Nissan dealer

Recall Description

Due to the location of the stop lamp switch on the brake pedal, a chattering condition may occur in the stop lamp relay. Under certain driving conditions, such as frequent stop-and go driving with repeated brake pedal input, the chattering can degrade the relay contact service life.

Remedy

Dealers will inspect the stop lamp switch position and set the gap to required specification. For early model year 2013 affected vehicles (prior to November 9, 2012), dealers will inspect the stop lamp switch position, set gap to required specification, and replace the stop lamp relay with a new one. For late model year 2013 to 2015 vehicles (produced after November 9, 2012, dealers will swap the stop lamp switch on the brake pedal with the Automatic Speed Control Device (ASCD) switch location on the brake pedal and then replace the stop lamp relay with a new one. This free service should take up to one (1) hour to complete but your Nissan dealer may require your vehicle for a longer period of time based upon their work schedule.

Recall #: R22A2 | PATH HOOD LOCK ASSY NTB22053 **Recall Date:** 2022 Jun 23

Recall Description

ON CERTAIN 2013-2016 PATHFINDER VEHICLES, DUST OR DIRT CONTAMINATION MAY ACCUMULATE ON AND AROUND THE SECONDARY LATCH LEVER PIVOT JOINT. OVER TIME, THE BUILD-UP OF CONTAMINATION, COMBINED WITH A LACK OF PROPER INSPECTION AND MAINTENANCE OF THE SECONDARY LATCH (AS DESCRIBED IN THE OWNER'S MANUAL), CAN CREATE MECHANICAL BINDING THAT COULD CAUSE THE LEVER TO REMAIN IN THE OPEN POSITION AFTER IT HAS BEEN DISENGAGED. IN ADDITION, THIS CONTAMINATION CAN SCRATCH THE SECONDARY LATCH'S PROTECTIVE ANTI-CORROSION COATING, ALLOWING CORROSION OF THE BARE METAL IN THE PIVOT JOINT.

Remedy

NISSAN WILL MAIL AFFECTED OWNERS AN INTERIM OWNER LETTER THAT WILL INSTRUCT THE OWNERS HOW TO PROPERLY INSPECT THE HOOD LOCK AND SECONDARY LATCH FOR PROPER WORKING CONDITION (NO STICKING). IF THE LEVER MOVES FREELY, THE OWNER CAN CLEAN AND CONDITION THE LEVER PER THE OWNER'S MANUAL GENERAL MAINTENANCE REQUIREMENTS IN SECTION 8 MAINTENANCE AND DIY. IF THE LEVER DOES NOT MOVE FREELY, THE CUSTOMER WILL BE INSTRUCTED TO TAKE THEIR VEHICLE TO A NISSAN DEALER. THE DEALER WILL INSPECT THE HOOD LOCK AND SECONDARY LATCH AND, IF FUNCTIONING PROPERLY, CLEAN AND CONDITION BY APPLYING LUBRICANT. IF EITHER OF THESE COMPONENTS DO NOT FUNCTION PROPERLY, THE HOOD LOCK AND/OR SECONDARY LATCH WILL BE REPLACED.
