

Recall #: SR-17-005 | 2015 OUTLANDER SPORT / RVR - REPLACE (2) ELECTRICAL POWER CONTRO Recall Date: 2017 Sep 29

### **Recall Description**

DUE TO AN INAPPROPRIATE MAINTENANCE PROCEDURE USED ON A WELDING MACHINE AT A RELAY SUPPLIER, WELDING OF COMPONENTS WITHIN THE RELAY MAY HAVE BEEN PERFORMED INCORRECTLY RESULTING IN IMPROPER ELECTRICAL CONDUCTION. AS A RESULT, ONE OF THE FOLLOWING CONDITIONS MAY OCCUR DEPENDING ON WHICH SYSTEM IS USING THE DEFECTIVE RELAY:-IF THE RELAY FOR THE ENGINE CONTROL UNIT FAILS, THE ENGINE WILL STALL WHILE DRIVING AND CANNOT BE RESTARTED.-IF THE RELAY FOR THE ENGINE VALVE LIFT CONTROL FAILS, THE ENGINE WARNING LAMP WILL ILLUMINATE AND FAIL-SAFE MODE WILL BE ACTIVATED, LIMITING AVAILABLE ENGINE POWER.-IF THE RELAY FOR THE RADIATOR FAN FAILS, THE ENGINE COOLANT TEMPERATURE WILL RISE, THE COOLANT TEMPERATURE WARNING LAMP WILL ILLUMINATE, AND THE ENGINE MAY OVERHEAT.

### Remedy

OWNERS OF ALL AFFECTED VEHICLES WILL BE NOTIFIED AND ENCOURAGED TO BRING THEIR VEHICLES IN TO REPLACE THE RELAY WITH A

COUNTERMEASURE UNIT.

Recall #: SR-18-002 | REAR PARKING BRAKE - 4A MODELS Recall Date: 2018 Jan 26

#### **Recall Description**

(1) DUE TO INSUFFICIENT RUST PREVENTION TO THE SHAFT OF PARKING BRAKE AND INSUFFICIENT SEALING PERFORMANCE OF THE REAR BRAKE CALIPER BOOT, WATER MAY PENETRATE INSIDE THE CALIPER AND THE PARKING BRAKE OPERATING SHAFT, CAUSING THE CALIPER BODY AND THE SHAFT CORROSION. AS A RESULT, THE SHAFT MAY POTENTIALLY BECOME STUCK, CAUSING BRAKE DRAGGING AND/OR PARKING BRAKE PERFORMANCE DECREASING.(2) DUE TO INADEQUATE MANUFACTURING PROCESS, AUTOMATIC ADJUSTER FOR BRAKE PAD CLEARANCE OF THE REAR BRAKE CALIPER WITH BUILT-IN PARKING BRAKE MAY NOT WORK. IF THEY OCCUR SIMULTANEOUSLY, AS BRAKE PADS WEAR, INVALID STROKE OF PARKING BRAKE LEVER WILL INCREASE, FINALLY PARKING BRAKE WILL NOT WORK EVEN THOUGH THE LEVER IS FULLY OPERATED.

#### Remedy

OWNERS OF ALL AFFECTED VEHICLES WILL BE NOTIFIED AND ENCOURAGED TO BRING THEIR VEHICLES IN TO CHECK AND REPAIR THE REAR BRAKE. (1) IF CALIPER BODY IS FOUND TO BE CORRODED OR SHAFT IS FOUND TO BE STUCK, THE BRAKE CALIPER BODY ASSEMBLY WILL BE REPLACED WITH A COUNTERMEASURE UNIT. OTHERWISE, THE BOOT AND LEVER WILL BE REPLACED WITH A COUNTERMEASURE UNIT. (2) THE PISTON ASSEMBLY OF THE REAR BRAKE CALIPER WILL BE REPLACED WITH A COUNTERMEASURE UNIT.

### **Recall Description**

IN THE EVENT THAT WATER DROPS DOWN THROUGH THE BACK SIDE OF THE FRONT DECK GARNISH (THE BODY PIECE BETWEEN THE HOOD AND WINDSHIELD), THE FRONT WIPER LINK BALL JOINT MAY EXPERIENCE EXCESSIVE MOISTURE AND CORRODE. IF THIS OCCURS, THE RESIN CASE OF THE BALL JOINT WILL WEAR PREMATURELY DUE TO THE BALL JOINT CORROSION AND THE WIPER LINK MAY ULTIMATELY SEPARATE CAUSING THE WINDSHIELD WIPERS TO STOP OPERATING.

## Remedy

OWNERS OF ALL AFFECTED VEHICLES WILL BE NOTIFIED AND ENCOURAGED TO BRING THEIR VEHICLES IN TO REPLACE THE ROD OF WIPER LINK WITH A COUNTERMEASURE UNIT. THE WIPER MOTOR CRANK ARM WILL ALSO BE REPLACED WITH NEW ONE. THE REPAIR WILL BE PERFORMED AT NO CHARGE TO THE VEHICLE OWNERS. OWNERS SEEKING REIMBURSEMENT FOR ANY EXPENSES ASSOCIATED WITH THIS RECALL WILL BE DIRECTED IN THE NOTIFICATION LETTER TO CONTACT THE MITSUBISHI CUSTOMER RELATIONS DEPARTMENT FOR REIMBURSEMENT CONSIDERATION.

Recall #: SR-20-003 | FRT CROSSMEMBER CORROSION - 14MY &15MY OUTLANDER SPORT (4A) Recall Date: 2020 Jul 28

### **Recall Description**

THE INSIDE AND OUTSIDE SURFACES OF THE FRONT CROSS MEMBERS USED ON CERTAIN VEHICLES, IF EXPOSED LONG TERM TO SNOWMELT WATER AND ANTI-FREEZING AGENTS, MAY CORRODE DUE TO INSUFFICIENT PERFORMANCE OF THE RUST PROTECTION. SHOULD SIGNIFICANT CORROSION OCCUR OVER TIME, A LOWER CONTROL ARM COULD EVENTUALLY BECOME DETACHED RESULTING IN LOSS OF VEHICLE CONTROL AND A POTENTIAL COLLISION.

#### Remedy

OWNERS OF ALL AFFECTED VEHICLES WILL BE NOTIFIED AND ENCOURAGED TO BRING IN THEIR VEHICLES FOR INSPECTION. THE CROSS MEMBER WILL BE INSPECTED AND THE FOLLOWING ACTION WILL BE TAKEN AT NO CHARGE TO THE CUSTOMER: (1) IF NO SIGNIFICANT CORROSION IS IDENTIFIED, A SEALING/ANTI-CORROSION AGENT WILL BE SPRAYED INSIDE/OUTSIDE THE CROSS MEMBER; (2) IN THE EVENT THAT SIGNIFICANT CORROSION IS IDENTIFIED, THE CROSS MEMBER WILL BE REPLACED WITH A COUNTERMEASURE CROSS MEMBER.

OWNERS SEEKING REIMBURSEMENT FOR ANY EXPENSES ASSOCIATED WITH THIS RECALL WILL BE DIRECTED IN THE NOTIFICATION LETTER TO CONTACT THE MITSUBISHI CUSTOMER RELATIONS DEPARTMENT FOR INSTRUCTIONS ON HOW TO APPLY FOR A REFUND.
