Open Recalls

Recall #: 9LG | - Potential Floor Mat Interference with Accelerator Pedal Recall Date: 2009 Oct 05

Recall Description

Lexus is recalling certain model year 2004-2010 passenger vehicles. The accelerator pedal can get stuck in the wide open position due to its being trapped by an unsecured or incompatible driver's floor mat.

Remedy

Toyota filed an amended defect report on November 25, 2009, stating that dealers will modify the accelerator pedal and, on certain vehicles, alter the shape of the floor surface under the pedal. These changes address the risk of pedal entrapment due to interference with the floor mat. Redesigned accelerator pedals will become available beginning in April 2010 and dealers will replace any modified pedal with the new pedal if desired. Also, dealers will replace any genuine Toyota or Lexus all-weather floor mats with redesigned all-weather mats, or repurchase the previous mats from owners who do not want the new ones. Additionally, software modifications will be installed on Camry, Avalon and Lexus ES 350, IS 350 and IS 250 models that will ensure that the brake overrides the accelerator in the event both brake and accelerator pedals are applied. Recall #: HLA | - Remedy Notice Multiple Models and Model Years Takata Front Passenger Airbag Inflator (Zone C) Recall Date: 2018 Jan 09

Recall Description

The subject vehicles are equipped with front passenger airbag inflators produced by Takata. The propellant in these inflators may degrade after prolonged exposure to high absolute humidity and fluctuating

high temperatures. Degraded propellant can cause the inflator to explode during airbag deployment.
