### Recall Description

The subject vehicles may be equipped with an electronic control unit (ECU) from a specific supplier designed to receive signals from crash sensors and deploy the airbags and seat belt pretensioners. The ECU may not have adequate protection against certain electrical noise that can occur in certain crashes, such as severe underride crashes.

### Remedy

Any authorized Toyota dealer will install a noise filter between the airbag control module and its wire harness FREE OF CHARGE.
