Recall Description

General Motors has decided to conduct a voluntary emissions recall involving certain 2015-2017 Chevrolet City Express vehicles. The engine control module (ECM) in these vehicles may not be able to properly diagnose reduced efficiency issues within the catalytic converter. If the catalytic converter's efficiency would become reduced, tailpipe emissions could exceed acceptable standards without illuminating the Malfunction Indicator Lamp (Check Engine Light).

Remedy

Dealers are to reprogram the engine control module.
