Recall Description

The subject vehicles may be equipped with an electronic control unit (ECU) designed to receive signals from crash sensors and deploy the air bags and seat belt pretensioners. The ECU does not have adequate protection against certain electrical noise that can occur in certain severe underride crashes.

Remedy

Any authorized Toyota dealer will install a noise filter between the airbag control module and its wire harness FREE OF CHARGE
