

Recall Description

CERTAIN 2014-2020 ROGUE AND 2017-2022 ROGUE SPORT VEHICLES ARE EQUIPPED WITH A JACKKNIFE KEY THAT MAY NOT HOLD THE KEY BLADE IN THE EXTENDED OPEN POSITION. OVER TIME THE INTERNAL PIVOT OF THE JACKKNIFE KEY MAY WEAKEN AND THE KEY COULD UNLOCK AND ROTATE DOWNWARDS.

Remedy

THE FINAL REMEDY IS NOW AVAILABLE. THE DEALER WILL INSERT A SPACER INTO THE KEY BLADE STORAGE SLOT OF THE FOB SO THE KEY BLADE IS IN THE EXTENDED OPEN POSITION AND CANNOT BE FOLDED DOWN. OWNERS SHOULD BRING ALL KEYS AND FOBS FOR THE AFFECTED VEHICLE WITH THEM TO THE DEALERSHIP WHEN HAVING THE REMEDY PERFORMED, AS THE REMEDY WILL RESULT IN DEACTIVATION OF ANY KEYS AND FOBS THAT ARE NOT REGISTERED AT THE TIME OF REPAIR.
