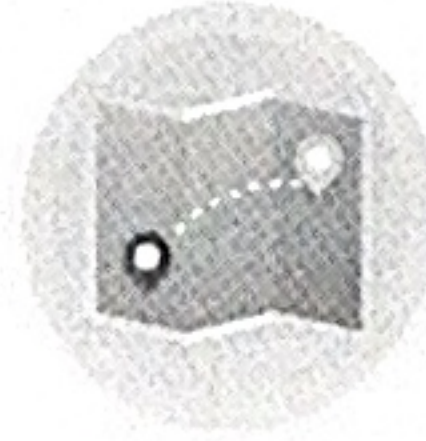

Recall Description

In the subject vehicles, there is a possibility that the parking brake could become inoperative.

Remedy

Any authorized Toyota dealer will install clips on the ends of the parking brake cables to prevent the parking brake from becoming inoperative. This repair will be performed at no cost to you.

Recall Description

The subject vehicles have an engine wire harness which is connected to the hybrid vehicle Power Control Unit. This connection has a connector cover. Due to assembly variation, a portion of the wire harness could contact the connector cover. If dust has accumulated on the wire harness or connector cover, vibration during vehicle use may cause the insulation on the wires to wear over time and expose the core wire.

Remedy

Any authorized dealer will check the engine wire harness assembly. If no damage is found, protective tape will be installed on the engine wire harness assembly. If damage is found, the engine wire harness assembly will be replaced with a new one, which includes a protector.
