#### **Recall Description**

SOME VEHICLES MAY EXPERIENCE AN INTERMITTENT LOSS OF THE TRANSMISSION OUTPUT SPEED SENSOR (OSS) SIGNAL TO THE POWERTRAIN CONTROL MODULE, POTENTIALLY RESULTING IN A TEMPORARY, UNINTENDED DOWNSHIFT INTO FIRST GEAR. IN SOME CASES, THE OSS SIGNAL COULD RECOVER WHILE DRIVING AND THE VEHICLE WILL RESUME NORMAL FUNCTION; IN OTHER CASES THE VEHICLE MAY NEED TO BE STOPPED AND RESTARTED TO REGAIN NORMAL TRANSMISSION OPERATION. FORD IS AWARE OF THREE REPORTS OF ACCIDENTS AND NO INJURIES RELATED TO THIS CONDITION ON THE AFFECTED VEHICLES.

#### Remedy

OWNERS WILL BE NOTIFIED BY MAIL AND INSTRUCTED TO TAKE THEIR VEHICLE TO A FORD OR LINCOLN DEALER TO HAVE THE POWERTRAIN CONTROL MODULE REPROGRAMMED WITH UPDATED SOFTWARE. THERE WILL BE NO CHARGE FOR THIS SERVICE. FORD IS EXCLUDING REIMBURSEMENT FOR COSTS BECAUSE THE ORIGINAL WARRANTY PROGRAM WOULD PROVIDE FOR A FREE REPAIR FOR THIS CONCERN. FORD WILL FORWARD A COPY OF THE NOTIFICATION LETTERS TO DEALERS TO THE AGENCY WHEN AVAILABLE.
