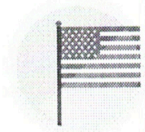

Recall Description

A NHTSA TEST FOR FMVSS 103 (DEFROST PERFORMANCE) FOUND A POTENTIAL NON-COMPLIANCE WHEN OPERATING THE DEFROSTER WITH OWNER S MANUAL INSTRUCTIONS. AT TEMPERATURES BELOW -10 C, USE OF THE BLOWER MOTOR AT FULL SPEED CAN CAUSE THE DEFROST FUNCTION TO OPERATE AT A LOW ELECTRICAL CURRENT AND TRIGGER FAILSAFE LOGIC. THIS MAY RESULT IN REDUCED DEFROST PERFORMANCE.

Remedy

NISSAN IS PROVIDING AFFECTED OWNERS WITH AN ADDENDUM TO THE OWNER S MANUAL WITH UPDATED INSTRUCTIONS ON HOW TO OPERATE THE DEFROSTER UNDER THE SUBJECT CONDITIONS. CUSTOMERS WILL BE ASKED TO ATTACH THE ADDENDUM TO THE VEHICLE OWNER S MANUAL. OWNERS WILL BE MAILED THE ADDENDUM WITH THE UPDATED INSTRUCTIONS IN MARCH 2023.
